**ENTRIES** - to the secretary of the meeting complete by **Friday 31<sup>st</sup> March**. Entry Fee £15.00 (Adults); £12.00 (Youth). Entries received after this date Adult £20, Youth £15. Club Subs are £5 (Adult) / £3 (Youth) to end of 2017.

**AWARDS** – On final result of the series, best three performances of four events to count. An award to the best performance in each class, subject to a minimum of 10 entries over the series, and two per event. First Class awards will be given for larger numbers. Classes: Expert (A); Clubman-Expert (AB); Clubman (B); Novice (C); Over 40; Over 50, T/S, Youth Expert and Youth A/B/C. Gradings stand as specified by the centre trials recorder. Points awarded to the performance at each event as per the Wessex championship system. Any uncompleted sections will be marked as 5 marks lost.

I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
